# Terms and Conditions

1. I declare and warrant that I am:
  - a. Asian heritage background,
  - b. Between the ages of 14 and 25 as of Feb. 11, 2009,
  - c. A Canadian citizen or landed immigrant,
  - d. Permanent residence of Canada,
  - e. Not under contract for any entertainment related talent,
  - f. Not a finalist in previous Young Asian Canadian Singing Competition,
  - g. Not a finalist in any Canadian Idol Competition.
2. I agree to pay a Registration Fee of \$10 at the registration for the Open Audition before being allowed entry to sing/perform at the Open Audition event
3. The winners (1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> places) of the Final Competition must agree to public appearances and to perform at special events as assigned by the Organizer for up to 12 months after the Final Competition.
4. I have read and agree to abide by the rules, regulations, terms and conditions of the Competition as revised from time to time by the Organizer and accept the decision of the Organizer as final and hereby acknowledge that the interests of the Competition shall override those of any Contestant.
5. I hereby assign irrevocably to the Organizer the entire copyright and all other rights to my audition, performance, and contribution to the Competition. The Organizer shall be entitled to use and exploit and license others to use and exploit such contribution, for the full term of copyright and thereafter insofar as is possible in perpetuity.
6. The Organizer shall be entitled to:
  - a. Change, add, or delete any parts of the Competition proceedings and formats.
  - b. Make and to authorize the making of any recording of my performance separately from or in conjunction with the Competition.
  - c. Include, or choose not to include, my name, likeness, voice, biographical details, photographs of me and recordings of interviews with me separately from or in conjunction with the Competition in all media and formats.
7. I acknowledge that no fees, royalties, or other consideration will be payable to me in respect of any broadcast, subsequent rebroadcast or any other use by the Organizer of the Competition in any manner or media format.
